#### OFFICIAL RULES

##### Eligibility

1. The Tamani Communities "Riversong Canoe Giveaway" (the "Contest") is open to residents of Riversong, Cochrane, Alberta who have reached the age of thirteen (13) years at the time of entry, except employees, representatives and agents, and members of their immediate families (i.e., parents, spouses, siblings, children, grandparents, step parents, step children and step siblings, and their respective spouses, and those living in the same household, whether or not related) of Tamani Communities ("Sponsor"), the contest administrator, LPi Communications Group Inc. ("LPi"), and their respective affiliated companies, parent companies, subsidiaries, participating promotional partners, advertising and promotion agencies, webmasters and any company involved in the creation, design, execution, production, or fulfillment of the contest (collectively, the "Contest Entities").

Only photos submitted in the comments section on the contest post are eligible to win.

Photos submitted in the following ways are not eligible to win:

- Photos tagged on personal pages
- Photos submitted through direct message
- Photos submitted on posts other than specified contest post
- Photos posted on the Riversong facebook page, not the contest post.

##### How to Enter

2. **No Purchase Necessary.** To enter the Contest, take a photo in the Riversong community, during the entry period beginning at 10:00 AM (Mountain Time MT) on April 25<sup>th</sup>, 2019 and ending at noon MT on May 24<sup>th</sup> 2019 (the "Contest Closing Time"). **Take a picture in the community of Riversong, post it on Facebook and you could win a 14' Escape Clipper Day Boat/Canoe worth approx. \$1,500.**

3. All entries must be received no later than the Contest Closing Time to be eligible to win a prize. Entries, which are incomplete, late, lost, irregular in any way or sent by an unauthorized method are void and will not be eligible or accepted at the time of the draw. Entries will only be accepted as described herein and will not be accepted by any other means.

4. By entering entrants consent to receiving electronic messages, and the collection, use, storage, and disclosure, of personal information by Sponsor for the purposes of conducting the contest.

**Note:** this Contest is no way sponsored, endorsed or administered by, or associated with Facebook. You completely release Facebook from any and all liability associated with this Contest. You understand that you are providing information to Sponsor and not to Facebook.

### **Prize Description**

5. There is two (2) prize available to be won. The prize consists of: A 14' 6" Escape Clipper Day Boat/Canoe. The prize value is approximately \$1,500.00. These are not BRAND new canoes. Tamani Communities owns the canoes and is giving them away to Riversong residents.

6. The prize supplier is an independent party over which Sponsor does not exercise any control. Sponsor is not responsible for any warranty, claims, losses, damages, costs, expenses, delays or loss of enjoyment relating to a prize.

7. Prizes must be accepted as awarded, and may not be assigned, substituted or redeemed for cash.

### **Contest Draw**

8. A random draw from all eligible entries received, will be made by Tamani Communities May 27th at 1:00 PM MT. The odds of winning are determined by the total number of valid entries received during the entry period. If any winner is under the age of eighteen (18) years a parent or legal guardian must accept the prize on their behalf.

### **How to Win**

9. To be declared a contest winner, the selected entrant will be required to correctly answer unaided (mechanical or otherwise), a time-limited mathematical skill-testing question by email, or telephone at a predetermined mutually convenient time. Following the draw described herein, the selected entrant will be contacted through Facebook. If the selected entrant cannot be reached within 48 hours, his or her entry may be forfeited and the next selected entrant drawn contacted. Such process will be repeated once, after which the prize may not be awarded. No communication or correspondence will be entered into, except with the selected entrant.

10. The prize must be picked up at a location designated by Sponsor. Winner must present one (1) piece of government issued photo ID when collecting a prize.

11. As a condition of winning and accepting the prize, the contest winner, shall sign a waiver, in the form requested by Sponsor, confirming compliance with the Official Rules, acceptance of the prize as awarded, and releasing Sponsor and all the Contest Entities from any liability associated with the Contest or the prize.
